#### From the Editor

On a different note, in an earlier issue of this newsletter I did a bit of a rant decrying the fact that Paralympians who medal have historically been paid nothing or much, much less than Olympians who do the same thing. This past week the Canadian Paralympic Committee (CPC) announced a new program that will enable Para-

lympians to be paid \$20,000 for a gold medal, \$15,000 for silver, and \$10,000 for bronze—the same as Olympic athletes. The president of CPC president Marc-André Fabien said the change represents an "historic day for Paralympic sport in Canada, and is the cumulation of years of work to create a more equitable, inclusive space for Canada's Paralympians to compete."

# Government programs of particular interest to seniors by Judy Hughes

#### Canada Dental Care Plan (CDCP)

The CDCP will be available to Canadian residents who

- have no access to dental insurance
- have an adjusted family net income of less than \$90,000
- are Canadian residents for tax purposes, and
- have filed their taxes in the previous year.

Applications opened for seniors aged 87+ in December 2023, and will expand in phases to those 77 to 86 in January 2024, followed by those 72 to 76 in February 2024, and then those 70 to 71 years in March 2024. Individuals in these age groups who may be eligible will receive letters inviting them to apply, with instructions on how to validate their eligibility and apply by telephone.

In May 2024, an online application portal will open for seniors 65 and older. Persons with a valid Disability Tax Credit certificate and children under the age of 18 will be able to apply online as of June 2024. All remaining eligible Canadian residents will be able to apply online in 2025.

To improve oral health outcomes, the CDCP will help cover the cost of various oral health care services, on the recommendations of an oral health care provider. Services that could be covered under the CDCP include the following, with some services only becoming available in fall 2024:

- preventive services, including scaling (cleaning), polishing, sealants, and fluoride;
- diagnostic services, including examinations and x-rays;
- restorative services, including fillings;
- endodontic services, including root canal treatments;
- prosthodontic services, including complete and partial removable dentures;
- periodontal services, including deep scaling;
- oral surgery services, including extractions.

### <u>The New Horizons for Seniors Program (NHSP)</u>

Through this program, the Federal government is investing \$60 million to fund more than 3,000 community-based projects across the country, which will make a difference in the lives of over half a million seniors across Canada. These projects, which include meal services, transportation, healthy aging and other priorities, help empower seniors and help seniors across the country keep active and remain socially engaged in the community.

#### Age Well at Home Initiative

The Federal government has invested \$90 million through the Age Well

at Home Initiative, which will provide funding for organizations across the country to provide practical services such as meal deliveries, house-keeping, yard work and snow removal to seniors in their communities, helping them stay in their homes and communities with dignity for as long as they wish.

#### Safe Long-Term Care Act

The Minister of Health and Minister for Seniors just wrapped up consultations for the Safe Long-Term Care Act—a bill that will be tabled in upcoming months to help make sure that what we saw in LTCs during the pandemic never happens again.

#### **Home Heating Program**

A member recently alerted me to the existence of a program that might benefit some of our members, and wanted me to share it with readers. I refer to the Home Heating Assistance Program offered by the PEI Government in partnership with the Salvation Army.

The Home Heating Program gives eligible Islanders up to \$1,200 per calendar year. Funding is available to individuals who pay their own heating costs and make up to \$45,000 per year, and to families making up to \$60,000. It can be used to help pay for a variety of heat sources—including oil, wood, wood pellets, and electricity.

## Group Insurance Inquiries by Dale Weldon, Johnson Inc.

The intent of this article is to deal with some service concerns and touches on phone and walk-in service.in PEI.

First, the phone system. The primary issue appears to be which choices to make to ensure that you get to the proper department to assist you with questions. As you go through the process, you will be presented with a number of options. Listen carefully to the choices presented. For the purposes of this article, let's assume that you are either calling about prescription drug coverage or about extended health benefits, such as hospital or paramedical coverage, vision care, etc.—the most common types of call. The toll-free number is 1-800-371-9516. [This is not the number on the back of your card, but either seems to work.]

First, assume that you are calling to ask whether a specific drug is covered. When you get an answer you will be given three choices—Public Service/CUPE, PEITF, or other. Select 2 for PEITF (because retired teachers' coverage is under this plan). From the next set of options, select 1 for All Claims. Next. select 1 for Health care/dental claims. Finally, select 1 for prescription claims and you will be automatically transferred to Medavie Blue Cross. Have your insurance card handy as you will be asked for your policy number and ID number.

If you are calling about extended benefits, such as hospital bed coverage or vision care, instead of selecting 1 in this last step, **select 3**.

There is a review project slated to

begin in the first quarter of 2024 to revamp the existing phone system to have fewer choices and clearer wording to lessen the instances of selecting the incorrect department. A future article will outline the updated process.

Staffing in our Charlottetown office continues to be challenging. Short term medical absences and the resignation of one of the administration staff has caused a short-term backlog which should be cleared up shortly, and there is active recruitment to fill the vacant position. Currently there are four agents in the office and once a replacement is hired, there will be five. Johnsons offers a hybrid work environment where staff are allowed to work from home on a predetermined schedule, but there will always be three staff working in the branch each day, barring any vacations or illnesses. For health claims processing, the receptionist will supply a claim form, assist with completion and ensure that all the necessary information is supplied, scan your claim form, and immediately email it to a member of the claims team for processing.

There are also many questions from members who are insured for Home and/or Automobile insurance. Any Unifund policy (owned by Johnson) will be converted to a BelAir Direct policy upon your renewal date in 2024. The reason for this is that Johnson's owner, Intact Financial Corporation, is not allowed to own two Home and Automobile insurance companies, namely Unifund and BelAir Direct, so that is the reason for the conversion. BelAir Direct offers superior coverage and benefits and in most cases is very competitive from a rate perspective. You will receive a letter notifying you of the

intent to transfer the policy and then you will be contacted by the sales team to assist you with the conversion.

the world after the United States and Switzerland. Canada has widely varying prescription drug coverage and uneven access to prescription drugs. Canadians often pay different rates for the same medication, depending on where they live. The idea of a national funded prescription drug program was recommended as the second half of the universal health care program in the Royal Commission on Health Care report in 1964.

"The Pharmacare 2020 study

indicated that the combined purchasing power of a National Pharmacare Program would save \$4 billion to \$11 billion a year in prescriptions. Further, by using evidence and information systems to guide drug coverage and prescribing, there would be a saving of \$5 billion a year to reduce the problems of overuse, underuse, and misuse."

I am sure this newsletter finds many of you enjoying, or anticipating, the sun and surf in a warmer climate. Maybe you are golfing? What about cruising? I hope you are doing whatever makes you happy! You have worked hard for the right to kick back every once in a while and relax.

We are at the midway point of another school year. 2024 will be an important year for Island teachers. Our Course Correction Campaign continues with the intent to enlighten the public to the challenges faced by teachers in today's classrooms. Challenges that if left unchecked will lead to a teacher shortage. Already the CSLF and the PSB are having difficulty filling French positions within their boards and the lack of substitute teachers is having a real impact on schools in West Prince and throughout the French Board. Fewer university students are applying to the education program and there is evidence that many recent graduates are choosing other careers. We need to turn this trend around!

By early spring, we will be entering into another round of bargaining with government. Our current collective agreement is set to expire at the end of this school year. The Economic Welfare Committee has been busy doing all the necessary work to be ready for negotiations. Teachers got their opportunity to voice their opinions through an Economic Welfare Survey that was developed and sent out with a rec-

ord number of teachers responding. Over one thousand members shared their thoughts on areas of concern including working conditions, impact of inflation, lack of substitute teachers, and class composition. No change however will occur to any of these areas if government doesn't return to good faith bargaining. The last couple of bargaining rounds ended in arbitration, which often will address salary but rarely tackles the issues that will lead to meaningful changes to working conditions.

Teachers keep teaching. Despite the

issues previously mentioned, teachers continue to go above and beyond. Science and Heritage Fairs are right around the corner. News platforms and social media posts are full of reports of outstanding student achievement in music, sports, drama, and academics, thanks to the many dedicated teachers who are guiding our

students to excel in all these areas. School administrators and teachers are comforting and counselling our kids through some horrific situations that have been occurring recently in many of our schools. Recent tragedies in Montague High, Vernon River Consolidated, and Tignish Elementary have shaken our communities, but thanks in large part to the leadership of our educators we are getting through it all together. You know as well as I do that teaching is so much more than standing in front of a class

#### **ETIAS**

In August [The Canadian Snowbird Association] notified members that Canadian citizens travelling to certain European countries will soon be required to obtain a permit known as a European Travel Information and Authorisation System (ETIAS) travel authorization. An ETIAS travel authorisation is an entry requirement for visaexempt nationals travelling to thirty European countries.

The ETIAS program was initially

scheduled to launch [this] year, but European officials have now announced that it is expected to be rolled out in **2025**. Last week, eu-Lisa – the agency responsible for the digital system – reported that it needs additional time to implement the program.

The Canadian Snowbird Association is carefully monitoring the progress of this program and will notify members as soon as new information is made available.



#### **PEITF Travel Insurance**

Our out-of-province travel insurance plan has a 90-day medical stability clause. This means that if you have a pre-existing medical condition, it must be considered medically stable for 90 days prior to your departure date if you are to be covered in the event of a medical emergency related to this condition while you are travelling.

A pre-existing condition is considered stable if the member, in the 90 days before the departure date, has not:

- Been treated or evaluated for new symptoms or related conditions;
- 2. Had symptoms that increased in frequency or severity, or examination findings indicating the condition has worsened;
- 3. Been prescribed a new treatment or change in treatment for the condition.
- 4. Been admitted to a hospital for the condition; or
- 5. Been awaiting new treatments or tests regarding the medical condition (does not include routine tests).

Number 3 generally does not include reductions in medication due to mprovement in a condition, or regular changes in medication as part of an established treatment plan—but each case must be reviewed individually. Call Medavie Blue Cross at 1-800-667-4511, Travel Department, for clarification if you are planning to travel outside PEI.
